

Beaufort County ranked seventh in the Southeast as one of the best places to live in rural America, and ranked as the 28th best county to live in among all U.S. rural counties, according to a study by The Progressive Farmer.

Beaufort County was the only county in South Carolina to make the Southeast Top 20 list.

Judging criteria included population density, income, healthcare, student-to-teacher ratios and the number of higher learning institutions, crime and pollution rates and the quality of life.



Drug Analysis Lab


Sheriff Tanner, through the use of Federal Grants, has established Beaufort County's first Drug Analysis Lab. Before this facility was established, suspected drugs seized by law enforcement were sent to the South Carolina Law Enforcement Division for analysis. This in-house lab enables the Sheriff's Office to readily identify various drugs seized within the county. Sergeant Renita Berry, a certified chemist, is employed by the Sheriff's Office to operate the Drug Analysis Lab.

Drugs Analyzed in 2004






Evidence Section

The Office for Professional Responsibility (OPR) is an administrative investigative branch within the Sheriff's Office specifically designated to fully investigate formal complaints lodged by citizens who believe that a law enforcement situation has not been handled satisfactorily. This procedure allows for the protection of the interests of both the citizen and the law enforcement officer.

Staff Sergeant Matt Averill, OPR for the Beaufort County Sheriff's Office, investigates all warranted complaints against Department personnel.




The Beaufort County Sheriff's Office Enforcement Division is responsible for all uniformed patrol functions and investigative procedures throughout the county. Staffed by over 120 law enforcement officers, this division is comprised of the following units: Enforcement Patrol, Investigations, Victim's Advocacy, Sex Offender Registry Management and Marine/Beach Patrol. During 2004, these deputies responded to over 111,616 calls for service. In addition to responding to calls for service, they conduct investigations, lend support to victims and their families, register sex offenders, serve warrants, conduct traffic stops and initiate proactive calls to businesses and residences.



Commanded by Major David Randall, the Enforcement Division is divided into two branches: the Northern Enforcement Branch, which includes the Beaufort County territory north of the Broad River Bridge, and the Southern Enforcement Branch, which includes the Beaufort County territory south of the Broad River Bridge. The Northern Enforcement Branch is managed by Captain Allen Horton and Lieutenant James Bukoffsky, while the Southern Enforcement Branch is managed by Captain Julian Walls, Lieutenant Marvin Morrison and Lieutenant Toby McSwain.





The Beaufort County Sheriff's Office Investigations Unit is responsible for all detailed and technical criminal investigations not assigned to the Patrol Unit. There are seven investigators assigned to the Northern Enforcement Branch and eight assigned to the Southern Enforcement Branch.

Victim's Advocacy Program


The Beaufort County Sheriff's Office Victim's Advocacy Program is designed to serve as liaison between the State and the victim, lending support to the victim and family members. Our Victim's Advocates are familiar with all statutes of law pertaining to victim rights and work to ensure that the Sheriff's Office protects those rights.

Beaufort County's crime victims are assisted by two Victim's Advocate officers. Sergeant Maybelle Scott is assigned to the Northern Branch and can be reached at (843) 470-3717. Corporal Prince Norton, with the Southern Branch, can be reached at (843) 842-4111.

Sex Offender Registry Management

According to state statute (Statute 23-3-400), the sheriff of each county is responsible for registering all sex offenders convicted of offenses that warrant registration and for maintaining a file on each offender to include a fingerprint card, current rap sheet, registration form, and photograph of the offender. When a convicted sex offender fails to register with Beaufort County Sheriff's Office, the appropriate action is taken to affect the registration (Statute 23-3-450). 
Marine/Beach Patrol Unit

With over 250,000 beachgoers each year, beach patrol is a necessary and effective form of law enforcement for those who visit our beautiful beaches and waterways. Assisted by the Department of Natural Resources and the U.S. Coast Guard, the Beaufort County Sheriff's Office Marine/Beach Patrol Unit provides year-round service to Beaufort County residents, guests and visitors.

This unit utilizes two watercraft, ranging in size from 22 feet to 24 feet. Seasonal beach patrol is also provided for the public beaches on Hilton Head Island and Hunting Island State Park with the use of all-terrain vehicles.




Commanded by Major Darryl Butler, the Administration Division consists of two separate branches: the Administrative Branch and the Support Branch. The Administrative Branch, managed by Captain Richard Roper, provides pro-active, non-traditional law enforcement as well as traditional support functions. The Support Branch, managed by Captain Ethan George, consists of specially trained units (commonly referred to as SWAT, K-9, etc.) who are equipped to respond to non-traditional law enforcement situations.




2004 Criminal Records Statistics

Criminal Records Section

The Criminal Records Section is primarily responsible for the maintenance and proper storage of all written records. This section provides the South Carolina Law Enforcement Division with arrest data for Uniform Crime Reporting Statistics. Additionally, the Criminal Records Section processes incident reports, fingerprint cards, tickets, subpoenas, background/criminal history requests, insurance requests, Freedom of Information Act requests, telephone inquiries and walk-in requests.



2004 Criminal Intelligence Statistics




Criminal Intelligence Unit

The Criminal Intelligence Unit is primarily responsible for the gathering of criminal intelligence data, the compilation of statistics based on this data, and the submission of South Carolina Incident Based Reporting to the South Carolina Law Enforcement Division (S.L.E.D.). This unit assists with interdepartmental analysis of criminal and reporting, while also facilitating the sharing of criminal intelligence data between the Sheriff's Office and other local, state and federal law enforcement agencies.




2004 Civil Process Unit Statistics




Civil Process Unit

The Civil Process Unit is tasked with serving court orders such as subpoenas, judgments and evictions. These officers also transport emotionally disturbed persons who are committed by Probate Court to various in-house treatment centers around the state. Tasked with providing assistance to the Enforcement Division as emergency circumstances may dictate, Civil Process officers routinely direct traffic at major accident scenes, stand post on perimeters during manhunts for wanted felons, and provide exterior security during barricaded subject situations in support of the Special Weapons and Tactics (S.W.A.T.) Team.








Warrants Unit



2004 Warrants Clerk Statistics - Warrants/Bench Warrants Received






2004 General Sessions Indictment Statistics




General Sessions Court Unit

2004 General Sessions Clerk Statistics





Courthouse Security Unit


The Courthouse Security Unit provides security for the Beaufort County Courthouse. The officers assigned to this unit are responsible for the overall safety and security of all courtroom visitors, employees, jurors, judges and defendants.



Auditor's Office Ligison

The Auditor's Office Liaison, Sergeant Neal Player, is responsible for locating residents who have failed to pay their Beaufort County property taxes and for issuing letters to these delinquent taxpayers, explaining the law regarding county property tax and the penalties for disregarding tax notices.

In 2004, Sergeant Player issued 1,060 letters to Beaufort County citizens in reference to unpaid Beaufort County property taxes. As a result of his investigations, he assisted in the collection of \$190,478 in property tax money.

Juvenile Services also provides law enforcement for community events and assists other divisions of the Sheriff's Office as needed. 





Success, Motivation and Responsibility Training (S.M.A.R.T.)

The S.M.A.R.T. Program is designed to equip at-risk juveniles with skills and life principles necessary for successful goal setting and achievement, and to provide tools and resources for the authority figures involved in the daily lives of these juveniles. This program is employed as a deterrent for first-time non-violent student offenders between ten and sixteen years of age who seem to be heading toward criminal behavior. Recruiting Section

Comprised of almost 200 law enforcement officers, the Beaufort County Sheriff's Office is among the most competitive agencies in the Southeast. Based upon experience and education, starting salaries range from \$27,682 to \$50,641. Officers possessing a degree of higher education receive a 3% salary increase for each degree earned. Additionally,



Reserve Deputy Sheriff Program

The Reserve Deputy Sheriff Program is a volunteer program that provides Beaufort County citizens with opportunity to gain law enforcement training and experience as they perform a much needed and appreciated service for their community. Those accepted into this program must participate in a minimum of 70 hours of training, which takes place during weeknight and weekend hours. Crisis Negotiation Team

The Beaufort County Sheriff's Office Crisis Negotiation Team is specifically trained in the use of negotiation techniques designed to diffuse and resolve critical, high risk situations. Incidents involving barricaded subjects, hostage-takers, or persons threatening suicide represent especially trying and stressful moments for the law enforcement personnel who respond to them. When called upon, Crisis Negotiators must be able establish contact with these individuals, identify their demands and work collectively to resolve tense and often volatile standoffs without loss of life. Prepared to respond to any part of Beaufort County or adjacent jurisdiction upon request, the Crisis Negotiation Team is on call seven days a week, twenty-four hours a day.



Airport Security Program

The Beaufort County Sheriff's Office Airport Security Program is designed to safeguard the civil aviation industry and the traveling public of Beaufort County. In order to ensure a safe and secure environment in which airport tenants may conduct business, Airport Security Officers identify security problems and offer recommendations toward corrective action. They also serve as liaison between Federal Aviation Administration (F.A.A.) civil security personnel and other law enforcement agencies who are tasked with aviation security responsibilities.

K-9 Unit

The Beaufort County Sheriff's Office maintains a full service K-9 Unit that is divided into two teams: the Patrol/Narcotic Dog Team and the K-9 Tracking Team. This unit utilizes specific breeds of dogs to carry out specific tasks. For example, the Belgian Malinois is used for full-service patrol, Black Labrador Retrievers for drug detection, and Bloodhounds for criminal apprehension as well as for locating lost or missing persons.

Special Weapons and Tactics Team (S.W.A.T.)

Specialized training and equipment enable the Special Weapons and Tactics Team (S.W.A.T.) to handle non-traditional and/or life-threatening situations more effectively than regular law enforcement units. The S.W.A.T. Team assists in cases involving such situations as barricaded suspects, hostage rescues, downed officer/citizen rescues, drug raids, attempted suicides, high risk warrant services and VIP escorts. This team also assists with specialized training for deputies in other units. In addition to local law enforcement duties, the S.W.A.T. Team lends support in specialized operations conducted by federal agencies such as the United States Secret Service, the Drug Enforcement Administration, the Bureau of Alcohol Tobacco and Firearms, the Federal Bureau of Investigation, and the United States Marshal's Service.

Multi-Jurisdiction Drug Task Force

The Multi-Jurisdiction Drug Task Force consists of law enforcement officers from the Beaufort County Sheriff's Office, the Beaufort Police Department, and the Naval Investigative Service (N.I.S.) who focus on the investigation of illegal drug activity and street crime. They use investigative techniques such as drug information collection and storage, use of informants, controlled drug buys, reverse "sting" operations, surveillance, interdiction methods, and undercover operations. These methods are used to produce evidence resulting in the arrest and prosecution of criminals.

The Drug Task Force Team is dedicated to reducing the flow of illegal drugs in Beaufort County and other communities throughout the State of South Carolina. They work to identify, arrest, and prosecute violators who illegally possess, use, distribute or manufacture illicit drugs. The removal of these criminals from our community plays a significant part in reducing the commission of violent and drug-related street crimes. This reduction in occurrence of violent street crime creates a better environment for all Beaufort County residents as well as for our visitors and guests.






Traffic Management Unit




2004 Traffic Management Unit Statistics



Animal Control Unit

The Animal Control Unit of the Beaufort County Sheriff's Office works to promote responsible pet ownership, prevent the spread of animal borne diseases and protect the public by seizing unrestrained animals roaming throughout the county. This branch is also responsible for providing a temporary shelter for stray and unwanted animals, for maintaining a vigorous program to reunite stray pets with owners and for providing a successful adoption program for those animals.



















The Citizen Police Academy (CPA) is a community oriented program designed to provide interested citizens with quality interactive training regarding law enforcement activity in Beaufort County. Since the CPA's inception in 2002, eleven sessions have been offered during which over 700 Beaufort County citizens have enrolled as students.



During each CPA classroom session, a wide variety of topics is discussed: incident response, citizen-police communication, crime penalties, crime prevention and many other subjects relating to law enforcement. Division representatives from the Sheriff's Office are available to discuss departmental activities and programs such as crisis negotiations, traffic management, juvenile services and many others.



Several CPA sessions take place outside of the classroom. Students are taken on a tour of the Beaufort County Law Enforcement Center, the Beaufort County Detention Center, and the Beaufort County Courthouse. They are allowed to observe a special training demonstration presented by the Special Weapons and Tactics (SWAT) Team and the K-9 Unit . And finally, CPA graduates are given opportunity to go on a ride-along with a patrol officer.









Any Beaufort County citizen wishing to attend the Citizens Police Academy must be at least 18 years of age, must pass the Sheriff's Office criminal history check and must receive favorable recommendations from all personal and professional references.
